*Legal Definitions of Sexual Assault in the State of Wisconsin

First Degree Sexual Assault: Whoever does ANY of the following is guilty of a Class B felony.

- 1. Has sexual contact or sexual intercourse with another person without consent of that person and causes pregnancy or great bodily harm to that person;
- 2. Has another person use of a dangerous weapon or any article fashioned in a manner to lead the victim reasonably to believe it to be a dangerous weapon;
- 3. Is aided or abetted by one or more persons and has sexual contact or sexual intercourse with another person without consent of that person by use or threat of force or violence.

Second Degree Sexual Assault: Whoever does **ANY** of the following is guilty of a Class C felony.

- 1. Has sexual contact or sexual intercourse with another person without consent of that person by use or threat of force or violence;
- 2. Has sexual contact or sexual intercourse with another person without consent of that person and causes injury, illness, disease, impairment of sexual or reproductive organ, or mental anguish requiring psychiatric care for the victim;
- 3. Has sexual contact or sexual intercourse with a person who suffers from a mental illness or deficiency which renders that person temporarily or permanently incapable of appraising the person's conduct, and the defendant knows of such condition;
- 4. Has sexual contact or sexual intercourse with a person who is under the influence of an intoxicant to a degree which renders that person incapable of giving consent if the defendant has actual knowledge that the person is incapable of giving consent and has the purpose to have sexual contact or sexual intercourse with the person while the person is incapable of giving consent;
- 5. Has sexual contact or sexual intercourse with a person who the defendant knows is unconscious;
- 6. Is aided or abetted by one or more other persons and has sexual contact or sexual intercourse with another person without the consent of that person.

Third Degree Sexual Assault is sexual intercourse with a person accomplished without the consent of that person. Third degree assault is a Class G felony.

Fourth Degree Sexual Assault is any sexual contact with a person without the consent of that person. Fourth degree sexual assault is a Class A misdemeanor.

**Location of Assault Definitions

On campus: (a) any building or property owned or controlled by an institution of higher education within the same reasonably contiguous geographic area of the institution and used by the institution in direct support of, or in a manner related to, the institution's educational purposes, including residence halls; and (b) property within the same reasonably contiguous geographic area of the institution that is owned by the institution but controlled by another person, is used by students, and supports institutional purposes (such as a food or other retail vendor).

Public property: All public property that is within the same reasonably contiguous geographic area of the institution, such as a sidewalk, a street, other thoroughfare, or parking facility, and is adjacent to a facility owned or controlled by the institution if the facility is used by the institution in direct support of, or in a manner related to the institution's educational purposes.

Other: Although it is not required to report those assaults that took place in any other geographic areas than those outlined above, the Student Development Office would like to continue gathering statistics for any assault that is reported – please be as specific as possible regarding location.
