## CONSULTATION

## IN AN EMERGENCY

If you believe that a student is in need of emergency help, stay calm and remain with that student. If your safety is threatened, immediately remove yourself to a safe location.

For students expressing a direct threat to themselves or others, or who act in a disruptive, bizarre, or highly irrational way, immediately call the campus switchboard at (920) 261-9300. For behavior that is life threatening, immediately call 911.

## PHYSICAL & SEXUAL ABUSE

Anyone who is experiencing or who has knowledge of physical or sexual abuse/assault should immediately contact law enforcement officials. Reports of abuse or assault can be made without fear of reprisal or retaliation by the university.

## DISCRIMINATION
